MORE CREDITORS. THE CERTIFICATE OF MAILING MUST BE FILED WITH THE CLERK WITHIN FIVE  
DAYS OF THE MAILING OF THIS NOTICE TO THE ADDED CREDITOR(S), THE CASE TRUSTEE, AND THE  
U.S. TRUSTEE. ALSO, YOU SHOULD ENCLOSE WITH EACH ADDED CREDITOR'S COPY OF THIS NOTICE  
A COPY OF THE FIRST SCHEDULED §341 MEETING NOTICE.

if the added creditor wishes to examine the debtor(s) under oath.

The added creditor has the right within sixty (60) days of the date of this  
notice to file a complaint objecting to the discharge of the debtor(s), or a complaint  
to determine the dischargeability of a debt, or to file a motion requesting an  
extension of time to file such a complaint, unless a longer period of time is provided  
by the Federal Rules of Bankruptcy Procedure. Any such complaint or motion must be  
filed in the Office of the Clerk of Court, P.O. Drawer 867, 205 Federal Building,  
Aberdeen, Mississippi 39730.

PLEASE TAKE NOTICE ALSO that the undersigned debtor(s) and/or the debtor(s)'  
attorney is required to send a copy of the amended schedule to each added creditor, to  
the case trustee and to the U.S. Trustee.
