COMPANY LOGO ARTWORK REQUIREMENTS

To help investors recognize companies listed on The NASDAQ Stock Market, NASDAQ uses company logos, where appropriate, instead of trading symbols, company logos are included on the MarketSiteSM Video Wall and Tower located in New York Times Square, the NASDAQ Web site, and NASDAQ Online.

GUIDELINES FOR ARTWORK

1. Please provide two (2) digital files of your logo according to the format requirements listed below:
 - one logo in color on a transparent background
 - one logo in white on a black background
2. All required registered marks, trademarks and service marks should be part of the logo artwork.
3. Corporate tag lines cannot be part of the logo artwork and should not be included.
4. All fonts used in vector-based applications (Adobe Illustrator, Macromedia Freehand) should be converted to outline art.
5. Hard copies of your logo on both a white and a black background should be provided, along with color specifications (Pantone[®] matching colors or the four-color process equivalent), with the digital files.
6. Corporate Logo Authorization Form should be completed and sent with logo artwork to address below.

FORMAT REQUIREMENTS

Logos must be in one of the following applications and file formats on a zip disk or cd (either Macintosh or PC):

- Adobe Illustrator – eps (**preferred**)
- Macromedia Freehand – eps
- Adobe Photoshop-compatible (any format, minimum image size of 1200 x 600 pixels), minimum 300 dpi, eps or tiff file.
- If your logo artwork does not exist in one of the above programs, artwork can be submitted as camera-ready art measuring at least 4" x 8". Black and white camera-ready artwork along with the Pantone color specifications will appear with more clear color than color camera-ready artwork.

UNUSABLE APPLICATIONS & FILE FORMATS

NASDAQ cannot accept logos in the following applications and file formats: Adobe PageMaker, MS PowerPoint, Corel Draw, MS Word, MS Excel, Quark XPress, JPEG, GIF, or BMP.
